New to Nursery Reminder

Children in Nursery who are eligible for 30 hours free childcare, are still required to pay for a school lunch. (£2.15) Thank you

You Could be eligible for free school meals

If you are eligible for Free School Meals but you have not claimed because your child brings a packed lunch to school, you may not be aware that the school receives additional funding that is used to support children who are entitled to Free School Meals, e.g. help towards the cost of educational visits and extracurricular activities etc.

Your child might be able to get free school meals if you get any of the following:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit Universal Credit provided you have an annual net income of no more that \pounds 7,400 as assessed by earnings from up to 3 of the most recent assessment periods (not including any benefits you get)
